# **NL-05** Regulator Station Rebuild

## Massapequa, NY| March 2024

Dear Neighbor,

We are returning to your neighborhood to complete outstanding work for our NL-05 Regulator Station Rebuild Project in Massapequa, NY. We paused construction back in November 2022 and will be finishing the last stages of work beginning this April 2024. This work is expected to be complete and restored in September 2024.

There will be no interruption to service for National Grid customers.

### What to expect during construction:

- Excavations. We will be excavating in roadway/sidewalk within the public right-of-way. All excavations will be plated during non-working hours.
- Noise disturbances. While excavations are underway, you may hear increased noise with the use of machinery.
- Traffic impacts on Clark Avenue & Hicksville Road. Street traffic will be open during construction to local traffic only on Clark Avenue. A flagger will be onsite to assist pedestrian and vehicular traffic. Please be aware of construction traffic signs and cones.
- Restoration. Our crews will fully restore disturbed roadways, sidewalks, and vegetation at the completion of our work in compliances with town specifications.
