We are about to begin an infrastructure improvement project in your area that will help to provide safe and reliable energy delivery to our customers. The Regulator Station NL-05 Improvement Project will increase the reliability of the system and the service to the community in Massapequa, NY.

### What to expect during construction:

- **Marking out of underground utilities** in the area.
- **Excavation** of the street and/or sidewalk.
- **Temporary changes to street parking.**
- **Traffic pattern changes.** Street traffic will be open during construction, and a flagger will be onsite during work hours. Please be aware of construction traffic signs and cones.
- **Street plates.** The project site will be secured and plated during non-work hours.
- **No interruption to gas service** for National Grid customers.
- **Restoration** of disturbed areas in accordance with the Town of Oyster Bay specifications.
- **Direct contact with our Outreach Team.** If you have questions or concerns, please call, or email our team.

### Scam Awareness:

National Grid staff and contractors are required to carry photo IDs. If someone requests entry and does not have proper ID, don't let that person in. Call National Grid at 1-718-643-4050 or your local law enforcement.

National Grid does not request payment in person for work being performed. If you are solicited for money related to services, do not provide any information, and call us immediately.
