Pursuant to the Agreement ESCO waives any claim against National Grid for making any payment under this Payment Instruction Authorization and, to the fullest extent allowed by law, ESCO agrees to indemnify, defend, and hold National Grid harmless from and against any losses, damages, claims, or liability (including reasonable attorneys' fees and court costs) which may at any time be imposed on, incurred by or asserted against National Grid by ESCO or any third parties (including Customers) that are directly or indirectly caused by, arise out of or under or are associated with, incident to or in connection with any assignment under Section 16 of the Agreement.

If there is a dispute in the future between ESCO and Third Party as to where any funds due ESCO should be remitted pursuant to the Agreement, National Grid shall continue to pay the funds into the above account until the dispute is resolved. ESCO and Third Party hereby agree not to initiate any legal proceedings of any nature against National Grid relating to such payment or such dispute and agree to hold National Grid harmless from any claims or liability relating to the Payment Instruction Authorization.

This Payment Authorization Instruction may not be amended, and no provision hereof may be waived, without the prior written consent of both Third Party and ESCO.

This Payment Authorization Instruction shall be governed by, and construed and enforced in accordance with, the laws of the Commonwealth of Massachusetts without giving effect to any choice of law or conflict of law rules or provisions (whether of the Commonwealth of Massachusetts or any other jurisdiction).
